MINUTES WAYCROSS CITY COMMISSION MEETING TUESDAY, APRIL 6, 2021 5:00 p.m.

The Commission of the City of Waycross held their Regular City Commission Meeting on Tuesday, April 6, 2021, in the Commission Chambers of City Hall. Mayor James calls the meeting to order at 5:00 p.m. Members in attendance were: Mayor Michael-Angelo James, Mayor Pro Tem Henry Strickland, Commissioners John Threat, Norman Davis, and Marian Solomon-Gaines. Commissioner Diane Hopkins was absent.

Mayor Michael-Angelo James offered the opening Invocation. Following the Invocation, Mayor James led the Pledge of Allegiance.

City Attorney Rick Currie set a public hearing scheduled for May 5, 2021, at 4:30 p.m. concerning the map amendment request for 951 Evans Way rezoning and a Budget Work Session for May 6, 2021, at 9:00 a.m.

Mayor Michael-Angelo James announced appointments for the Housing Authority as Dr. Martha Hall with the term ending March 21, 2024, Martin Eaves with the term ending March 21, 2025, and Cleo Price with the term ending March 21, 2022.

During the City Manager's & Mayor's Report, Acting City Manager Eddins discussed the community's Swamp Festival participation and wished Commissioner Norman Davis a Happy Birthday. Mayor James wished Norman Davis a Happy Birthday.

There were no public remarks on official action.

Mayor James presented the Consent Calendar as read by City Clerk Michelle Love for consideration of official action as follows:

City Clerk read the following ordinance as a second reading:

Commissioner Norman Davis motion for approval of the Consent Calendar and Commissioner Henry Strickland seconded the motion. All voted in favor, and the motion carried.

Commissioner Solomon-Gaines motioned for the approval. Commissioner Henry Strickland second the motion. The motion was approved.

Ms. Linda Jones, Purchasing Director, presented Bid Fy19 Gas Card Service Extension for Fy22 to the Commissioners. The bid is the same for another year. Commissioner Norman Davis made the motion to approve to award bid; Commissioner Diane Hopkins second the motion. An unanimous vote approved the motion.

Ms. Jones presented Bid #FY21 Albany Avenue Street Improvement to the Commissioners. Purchasing issued requests for division 1 and division 2. After staff review and evaluation, the recommendation to award the bid to Thrift Brother Inc. Commissioner Norman Davis made the motion to approve award the bid; seconded by Commissioner Marian Solomon-Gaines, and approved with a unanimous vote.

WHEREAS, Section 2.1 of the Charter of the City of Waycross gives the City of Waycross the power and authority to "enter into contracts and agreements with other governmental entities and with private persons, firms and corporations"; and

WHEREAS, said matter having been considered;

NOW, THEREFORE, BE IT RESOLVED by the Commission of the City of Waycross that the Mutual Release of Claims Agreement, a copy of which is attached hereto as an Exhibit and incorporated herein as if fully set out, between the City of Waycross and the Okefenokee Humane Society, Inc. be approved.

BE IT FURTHER RESOLVED that the Mayor, City Manager, City Clerk, City Attorney and Assistant City Attorney be authorized, directed and empowered to sign said Mutual Release of Claims Agreement, and also the Voluntary Dismissal with Prejudice, and to do all the acts and things necessary in order to carry out the purposes and intent of this Resolution.

RESOLUTION NO. R21-22

A RESOLUTION OF THE CITY OF WAYCROSS, GEORGIA, TO AWARD BID CONTRACT TO LEWIS AND RAULERSON, I.N.C. FOR FISCAL YEAR 2022 GAS CARD SERVICE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Waycross anticipates using approximately 100,000 gallons of unleaded fuel and approximately 40,000 gallons of low sulfur # 2 diesel during Fiscal Year 2022, being from July 1, 2021, until June 30, 2022; and

WHEREAS, in March 2018, the City of Waycross Purchasing Department offered the project through competitive bidding and received and opened bids tendered for the gas card service; and

WHEREAS, Lewis and Raulerson, Inc. of Waycross, Georgia, submitted the best value bid for the City, with a 5 cent (\$0.05) markup on gasoline, and a 7 cent (\$0.07) markup on low sulfur # 2 diesel; and they utilize FueLoc (the proprietary fleet fueling card program) and have multiple FueLoc locations in the City and across the State of Georgia; and

WHEREAS, the City Commission awarded the bid to Lewis and Raulerson, Inc. on March 20, 2018, said award including an additional four (4) one year renewals if all parties are in agreement, and which the parties are in agreement; and

WHEREAS, said matter having been considered.

NOW, THEREFORE, BE IT RESOLVED by the Commission of the City of Waycross that the Bid Contract for FY22 Annual Gas Card Service, awarded to Lewis and Raulerson, Inc.

on March 20, 2018, be extended and renewed for an additional fiscal year from July 1, 2021, until June 30, 2022, with all terms detailed in the original agreement continuing.

BE IT FURTHER RESOLVED that the Mayor, City Manager, and City Clerk be authorized and directed to execute the bid contract on behalf of the City of Waycross and to do all the acts and things necessary in order to carry out the purposes and intent of this Resolution.

RESOLUTION NO. R21-23

A RESOLUTION OF THE CITY OF WAYCROSS, GEORGIA, TO CANCEL AND TERMINATE CONTRACTS WITH UTILITY SERVICE COMPANY, I.N.C. OF PERRY, GEORGIA, FOR CITY'S ANNUAL WATER TANK MAINTENANCE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Waycross has a need for annual maintenance of its 7 water tanks; and

WHEREAS, in August 2000, the City entered into 5 separate maintenance contracts for each of the following water tanks: Industrial Boulevard Tank 1, Industrial Park South Tank 2, Marion Street Tank 5, M.L.K. Tank, and Stephenson Street Tank 7, with Utility Service Company, Inc. of Perry, Georgia (by Resolution No. 00-49, the City Commission did not approve the contracts until September 5, 2000); and

WHEREAS, the maintenance contract with Utility Service Company, Inc. for the Lowes Tank was executed and signed on October 18, 2005 (by Resolution No. 05-62, which was approved by the City Commission on October 18, 2005); and

WHEREAS, the maintenance contract with Utility Service Company, Inc. for the Alice Street Tank was executed and signed on November 7, 2007 (by Resolution No. 07-63 which was approved by the City Commission on November 5, 2007); and

WHEREAS, Utility Service Company of Perry, Georgia, has been acquired by Suez Environnement North America; and

WHEREAS, the City of Waycross now desires to cancel and terminate all of the abovementioned maintenance contracts; and

WHEREAS, said contracts require that the contracts are subject to cancellation or termination only if intent to cancel or terminate is received by Company ninety (90) days prior to the anniversary date or the first day of the upcoming Contract Year. Notice of Cancellation to be delivered by registered mail and signed by three (3) authorized voting officials of the Owner's management and/or Commissioners; and

WHEREAS, said matter having been considered.

NOW, THEREFORE, BE IT RESOLVED by the Commission of the City of Waycross that all of the above-described contracts for the City's Annual Water Tank Maintenance with Utility Service Company, Inc. (being Industrial Boulevard Tank 1, Industrial Park South Tank 2, Marion Street Tank 5, M.L.K. Tank, Stephenson Street Tank 7, Lowe's Tank and Alice Street Tank) are canceled and terminated.

BE IT FURTHER RESOLVED that the Mayor, City Manager, City Clerk and City Attorney be and are authorized and directed to execute any document on behalf of the City of Waycross canceling and terminating said contracts, attaching a copy of this Resolution as an Exhibit, and delivering said letter and Resolution to Utility Service Co., Inc. at 535 Courtney Hodges Boulevard, P.O. Box 1350; Perry, Georgia 31069, by registered mail, and to do all the acts and things necessary in order to carry out the purposes and intent of this Resolution.

A RESOLUTION OF THE CITY OF WAYCROSS, GEORGIA, TO AWARD BID CONTRACT TO EAST COAST ASHPALT L.L.C. FOR ALBANY AVENUE WIDENING AND RESURFACING PROJECT AND TO THRIFT BROTHERS INC. FOR ALBANY AVENUE DRAINAGE IMPROVEMENT PROJECT; AND FOR OTHER PURPOSES.

WHEREAS, Albany Avenue is in need of street repair, resurfacing and drainage improvement; and

WHEREAS, Albany Avenue is approved and listed as a Regional Transportation Special Purpose Local Option Sales Tax (Regional T-SPLOST) project for Waycross and Ware County and also approved as a Transportation Special Purpose Local Option Sales Tax (T-SPLOST) project; and

WHEREAS, the City Commission approved a Transportation Investment Act of 2010 Project Agreement with the GDOT for the Albany Avenue Widen and Resurfacing, SGRC-153, P.I. 0016312, project on or about October 1, 2019; and

WHEREAS, this bid was issued in two (2) divisions in order to obtain the best pricing – one for street repair and resurfacing and the other for drainage improvement; and

WHEREAS, the City of Waycross Purchasing Department offered the project by soliciting bids from all 7 local area road and construction contractors and also posted the request for bids on the City's website, GPR and in the local newspaper; and

WHEREAS, East Coast Asphalt L.L.C. of Douglas, Georgia, submitted the lowest and best bid for the Albany Avenue widening and resurfacing project in an amount of \$659,813.40 (which includes a deduction of \$7,500.00 for the City to retain all millings to use in other needed locations), and meeting all specifications and requirements; and

WHEREAS, Thrift Brothers, Inc. of Waycross, Georgia, submitted the lowest and best bid for the Albany Avenue drainage improvement (and which includes sewer replacement) project in an amount of \$2,468,233.70, and meeting all specifications and requirements; and

WHEREAS, said matter having been considered.

NOW, THEREFORE, BE IT RESOLVED b by the Waycross City Commission that the Bid Contract for the above-described Albany Avenue widening and resurfacing project be awarded to East Coast Asphalt L.L.C. of Douglas, Georgia, in an amount not to exceed \$659,813.40; that the Bid Contract for the above-described Albany Avenue drainage improvement (which includes sewer replacement) project be awarded to Thrift Brothers, Inc. of Waycross, Georgia, in an amount not to exceed \$2,468,233.70; and both projects to be paid from available Local and Regional T-SPLOST funds.

BE IT FURTHER RESOLVED that the Mayor, City Clerk, City Manager and City Attorney be authorized and directed to execute the Bid Contract on behalf of the City of Waycross, and to do all the acts and things necessary in order to carry out the purposes and intent of this Resolution.
