# MINUTES WAYCROSS CITY COMMISSION MEETING TUESDAY, MAY 18, 2021 5:00 p.m.

The Commission of the City of Waycross held their Regular City Commission Meeting on Tuesday, MAY18, 2021, in the Commission Chambers of City Hall. Mayor James calls the meeting to order at 5:00 p.m. Members in attendance were: Mayor Michael-Angelo James, Mayor Pro Tem Henry Strickland, Commissioners John Threat, Diane Hopkins, and Marian Solomon-Gaines. Commissioner Norman Davis was absent.

James Smart offered the opening Invocation. Following the Invocation, J a m e s led the Pledge of Allegiance.

City Attorney Rick Currie set a Budget Public Hearing scheduled for June 15, 2021, at 4:15 p.m.

City Attorney Rick Currie read the following ordinance first reading:

WHEREAS, an answer and responsive pleadings will need to be filed in the Complaint or judgment by default will be entered against the City of Waycross, et al; and

WHEREAS, said matter having been considered.

NOW, THEREFORE, BE IT RESOLVED by the Commission of the City of Waycross that Richard E. Curric, City Attorney for the City of Waycross, is directed to waive service of process, to file an answer, any other responsive or appropriate motions to said Complaint for Damages and provide a defense for the City to said Complaint filed by the Clement A. Evans Camp # 64 Sons of Confederate Veterans et al.; and the authority provided by this Resolution is given retroactive effect to any and all actions taken by the City Attorney since May 1, 2021.

## **RESOLUTION NO. 21-42**

A RESOLUTION OF THE CITY OF WAYCROSS, GEORGIA, TO AWARD A CONTRACT TO THRIFT BROTHERS, LLC FOR EMERGENCY REPAIR TO SINKHOLE ON LEE AVENUE AND EMERGENCY STORM DRAINAGE REPAIR ON BLACKSHEAR AVENUE; AND FOR OTHER PURPOSES.

WHEREAS, there was a sinkhole that formed on the southeast side of a vegetated island in a parking lot of the intersection of Lee Avenue and U.S. #1; and

WHEREAS, this work needs to be completed on an emergency basis since the sinkhole was likely caused by the failure of one or more storm drain pipes and/or a concrete arch culvert that runs under the parking lot; and

WHEREAS, there was also a section of falling sidewalk on the north side of Blackshear Avenue near the head of the existing box culvert and was likely being caused by erosion of the subgrade material underneath the sidewalk by stormwater that, if ignored, would cause more problems and repair need to be completed on an emergency basis; and

WHEREAS, in accordance with the Code of Ordinances of the City of Waycross, section 2-320 (b), the city manager or her designee used best efforts to obtain competitive pricing for said emergency services and all actions taken by the city manager or her designee were pursuant to Code section 2-320 and were otherwise reasonable under the circumstances; and

WHEREAS, bids were requested from our four (4) local contractors and only one responded with a bid, being Thrift Brothers LLC submitting the lowest and best bid for the project at a cost of \$101,861.00; and

WHEREAS, said matter having been considered.

NOW, THEREFORE, BE IT RESOLVED by the Commission of the City of Waycross that the City of Waycross proclaims an emergency and hereby approves the emergency procedures used by the city manager or her designee and that a contract be awarded to Thrift Brothers LLC for the contract price of not more than \$101,861.00 for the emergency repair to the sinkhole on Lee Avenue and the emergency storm drainage repair on Blackshear Avenue as described above.

BE IT FURTHER RESOLVED that the Mayor, Acting or Interim City Manager and City Clerk be authorized and directed to execute any Contract on behalf of the City of Waycross, and to do all the acts and things necessary in order to carry out the purposes

WHEREAS, Georgia Municipal Association has presented an agreement, a copy of which is attached, being 8 pages, and incorporated herein by reference as if fully set forth; and

WHEREAS, said matter being considered.

NOW, THEREFORE, BE IT RESOLVED by the Commission of the City of Waycross that the City of Waycross proclaims an emergency, pursuant to Code 2-320 (b), and authorizes on an interim basis but no more than six (6) weeks from the execution of the agreement, the approval of the Agreement for Georgia Municipal Association, Inc. to Provide Consulting Services for City of Waycross, a copy of which is attached hereto and incorporated by reference as if fully set forth, for guidance and expertise on Human Resources.
