# MINUTES WAYCROSS CITY COMMISSION MEETING TUESDAY, JANUARY 5, 2021 5:00 PM

The City Commission of the City of Waycross held their Regular Session on Tuesday, January 5, 2021 in the Commission Chambers of City Hall.
