MINUTES WAYCROSS CITY COMMISSION MEETING TUESDAY, FEBRUARY 2, 2021 5:00 PM

The Commission of the City of Waycross held their Regular City Commission Meeting on Tuesday, February 2, 2021 in the Commission Chambers of City Hall. The meeting was called to order at 5:00 p.m. by Mayor Michael-Angelo James. Members in attendance were: Mayor Michael-Angelo James, Mayor Pro Tem Henry Strickland, Commissioners Norman Davis, Diane Hopkins, and Marian Solomon-Gaines. Commissioner John Threat was absent.

Commissioner Norman Davis introduced Apostle Janice Thomas, who offered the opening invocation. The Invocation was followed by the Pledge of Allegiance led by Mayor James.

Chief Tommy Cox introduced Carla Nipper of the Police Department as the January Employee of the Month.

There were no public remarks on official action.

Mayor James presented the Consent Calendar as read by City Clerk Michelle Love for consideration of official action as follows:

No Ordinance was presented for second reading.

There were no Consent Resolutions or Privilege License Renewals.

The Consent Calendar was approved by motion from Commissioner Marian Solomon-Gaines, seconded by Commissioner Norman Davis. The motion passed with all votes.

Finance Director China Williams Agu presented Bid FY21-16 In Car Cameras and Body Cameras. Purchasing issued bids for 35 car cameras and 35 body cameras for the Waycross Police Department. 4 bids were received. After staff review, it is the recommendation to award the bid to WatchGuard of Allen, Texas. The total bid amount is \$235,800.00. Maintenance and licenses will be \$13,000.00 annually. Commissioner Norman Davis made the motion to approve the bid FY21-16. Commissioner Marian Solomon-Gaines seconded the motion. All Commissioners voted yes, and the motion passed.

A RESOLUTION OF THE CITY OF WAYCROSS, GEORGIA, TO APPROVE PURCHASE OF IN-CAR CAMERAS AND BODY CAMERAS FOR THE WAYCROSS POLICE DEPARTMENT; AND FOR OTHER PURPOSES.

WHEREAS, the City of Waycross Police Department has approved budgeted funds to purchase thirty-five (35) in-car cameras and thirty-five (35) body cameras for the Waycross Police Department; and

WHEREAS, the Purchasing Department offered the project for the thirty-five (35) in-car cameras and thirty-five (35) body cameras through competitive bidding, and received and opened four (4) bids tendered; and

WHEREAS, Watchguard of Allen, Texas, submitted the lowest and best proposal for the thirty-five (35) in-car cameras and thirty-five (35) body cameras; and

WHEREAS, said matter having been considered.

NOW, THEREFORE, BE IT RESOLVED by the Commission of the City of Waycross that the Contract for purchase of thirty-five (35) in-car cameras and thirty-five (35) body cameras from Watchguard of Allen, Texas, for a total price of \$235,800.00, with maintenance and licenses being \$13,650.00 annually, and to be paid for from Waycross Police Department budgeted funds.

BE IT FURTHER RESOLVED that the Mayor, City Clerk, City Director of Purchasing and City Attorney be authorized and directed to execute the Contract on behalf of the City of Waycross, and to do all the acts and things necessary in order to carry out the purposes and intent of this Resolution.

WHEREAS, the City of Waycross received Georgia Department of Community Affairs Community HOME Improvement (hereinafter "CHIP") funds for the year 2019, being grant number 2017-112, and is currently administering said grant; and

WHEREAS, the City Commission, in Ordinance Number 19-059, adopted on October 22, 2019, approved the homeowner's request for rehabilitation assistance in loan number CH17XWAYC-03 in the amount of \$39,778.00 for the property at 908 Quarterman Street; and

WHEREAS, a citizen, Nettie Williams, has a need for rehabilitation assistance and has completed the process and has been approved for rehabilitation assistance; and

WHEREAS, the original amount of the loan was for \$39,778.00 but a change order has increased the loan amount to \$45,675.00; and

WHEREAS, the City should request a draw on the C.H.I.P. grant from the Department of Community Improvement for improvements to the property located at 908 Quarterman Street; and

WHEREAS, said funds are available and the matter has been duly considered;

NOW, THEREFORE, BE IT RESOLVED by the Commission of the City of Waycross that the City of Waycross hereby approves Nettie Williams' request for rehabilitation assistance, being loan number CH17XWAYC-03, in compliance with the program policies adopted by the City of Waycross in the increased amount of \$45,675.00 to be paid from C.H.I.P. grant number 2017-112.
