I. CALL TO ORDER:

The Waycross City Commission Planning and Information Session was called to order on Monday, December 5, 2022, at 5:00 pm by Mayor Michael-Angelo James. The meeting was held in the Commission Chambers of City Hall. Present was Mayor James, Mayor Pro Temp, Diane Hopkins, Commissioners Norman Davis, Sheinita Bennett and Henry Strickland.

II. GUESTS:

Clint Bowman- 505 Ava Street, Waycross Georgia, 31501

Mr. Bowman, spoke briefly on writing up grant request for the Wynona Park Project, and is seeking a letter from the city, stating it is a city park. That the money should they receive, the grant would be for the park. It was stated by Interim City Manager, Marc Hawkins that he would need to see the letter from the people that would be offering the grant to see what they are looking for to apply. The city was not going to maintain the park because it is in the county. The discussion ended with trying to do some research to look for past discussion on the plans for that park.

Brenda McEady-922 Highsmith Street, Waycross Georgia, 31501

Mrs. McEady spoke briefly on the debris that is falling in her yard from the adjoining business when their property is being landscaped. She wanted to know if the city could do anything about that. (She brought in a bag of debris that she says is just some of what is on her property.)

David White- 1419 Marion Street, Waycross Georgia, 31501

Mr. White, spoke briefly on the need to have a traffic light at Blackwell and Corridor Z. He states that there was a recent accident with a Walmart truck. And he still feels there is a need to have a light there for the citizens who walk and must cross that intersection.

Marion Solomon Gaines- 404 Gilmore Street, Waycross, 31501

Ms. Solomon Gaines, spoke briefly on the article that was posted in the Shopper regarding Commissioner Felders position on not allowing Apartments in her district. She also spoke on her distaste for the "Make Waycross Great Again" signature of the composer of that article. She wanted to remind the commission that the citizens in district 3 has expressed to Commissioner Felder that they have no desire to have those apartments in their community, that if the Apartments were needed then allow them to be placed in district of the citizens who are complaining about not having them. She also spoke on the problem with Corridor Z and not having a light not only at Blackwell but out near Garlington Heights area.

Mr. Rood, spoke briefly on how thankful and grateful to Commissioner Felder on the job she is doing in district 3. She is listening to her community and adjusting to help in the best way she can. He also Spoke against the article in the shopper comparing it to the "Jim Crow Era" a time he vividly remembers as a child. He expressed a need to work together to keep progress moving forward not backwards

He stated that we all need to look at our country and see how important and beneficial working together is for our city.
